## Tuition Agreement and Payment Form

The Louisville Youth Choir is a not-for-profit 501(c)3 organization. LYC's main avenues of income are grant writing, fundraising and tuition. These monies are used to support the work of the youth choir including concert venue rentals, music purchases, marketing, printing and staffing. Tuition makes up approximately 33% of our total income.

Annual tuition is \$625 and can be prorated throughout the season to accommodate late starting dates. For families+ with more than one singer, the 2nd and additional singers will pay \$500. There is a required \$50 deposit due at the time of audition for all singers. The deposit is applied to the total tuition due. LYC offers three flexible payment options from which you may choose. Forms of payment accepted: cash, check or credit card.

**Plan A: Paid in Full\*** (Tuition is due within the first 30 days of beginning rehearsals.)

**Plan B: Tuition Paid Monthly\*\*** (Tuition payments due on the 1st of each month with a \$20 Maintenance Fee per semester. Maintenance fees applied to the first bill of each semester.) **Plan B+ Option:** Monthly payments charged to credit card automatically on the first of each month contracted for payment.

**Plan C (Available to Singers who sing September-April):** Tuition Paid in Two Installments\*\* (Installment #1 is due within the first 30 days of beginning rehearsals and Installment #2 is due on the 1st of January.)

\*There is a 5% discount if paid in full by June 30,

\*\* There will be a \$25 late fee added after the due date
